## Grant application status

Jim DeBoer applied for an EGLE grant for a continuous monitoring buoy. The grant is pending. We should hear within next month about whether we have received funding

Bob Smart submitted a Muskegon Community foundation grant - \$15,000 to monitor status of lake ten years after delisting. Interview went well. Another proposal was very similar. To find out the first week of April. The group discussed the importance of knowing the health of the lake.

## Life Jacket program training

Susan Day participated in a 3 afternoon conference with Sea Tow Foundation

She has applied for a grant for more life jackets – need XL, don't offer XXL through grant but we feel like we could use some. The program has less jackets available. Can get patches to put on jackets if we get our own to identify them as loaner lifejackets.

The group agreed to put donation boxes on stand for life jackets (all agree with stipulation that monies go for life jackets)

#### **Trash Bash**

April 21 1-4pm

Sara Kane-Smart – asked for input from Water Dog as to whether they will provide kayaks but hasn't heard back. Greg thinks they will. Maybe we can participate with the steelheaders and water shed folks to get more interest in extending the water coverage for the event. Bob and Sara will get ten reachers for kayakers to use. Will ask people with kayaks and waders to sign up on White Lake website. Will ask Float a palooza folks to come out. Mark has an aluminum boat we can use – kayaks are hard to use for trash pickup in his previous experience, especially with larger items.

## White Lake History Cruise July 28 three cruises at 1, 4, and 7pm

We are refreshment sponsor, get only two paid passes – go on sale June 1. This was approved via email in early November by the board. Silver sponsorship is \$500 and we get logo on posters and goody bag but only two tickets for the total of three cruises. Chris and Sara will go, Greg is a possible.

### Membership update

Member numbers? 158 members, 64% return rate on our mail drive, 19 new people. 123 provided email addresses, 34 did not. There were 20 that paid through pay pal. Remainder through snail mail. Sue can see name and email addresses of those who paid through pay pal.

We have discussed sending out request to join to all lake front property owners and will work to come up with a list to do so. We agree that we should ask if they want the given that costs us \$14 per year to send it. We discussed increasing dues and decided to keep it at \$35 but encourage additional donation

Sue received information from Constant Contact – email blast mechanism. We are currently suspended from the service. It would cost 193.20 for 12 months or 110.40 for six months. Sue is willing to make donation to support the 12 months to see if it is worth having. It can give you a report of who opened the email or which ones bounce back. We could send out the minutes of our meetings, consider a quarterly newsletter, send out the dues renewal notifications. We have voted to renew this for now through white lake funds.

Last year we made \$255 with tickets only sold day of event – Bob is willing to man the table. Hopefully we will be able to have the location at Fetch. All agreed to participate.

## Travel policy discussion and approval.

After discussion, Greg moved that the association will pay for registration fees for a board member or volunteer to attend an educational conference on fresh water with the attendee coming back to present information to the board. Travel costs will not be covered. Motion was seconded by Susan Day and approved by all board members

Board approved payment of registration fees for Jim Deboer to attend conference next month.
